## **REGULAR MEETING -BOARD OF TRUSTEES- JANUARY 15, 2019-7:00 P.M.**

The meeting began with The Pledge of Allegiance and a moment of silence.

The Mayor stated she appointed Judy Wood-Zeno as Deputy Mayor and Deputy Mayor Zeno took her oath of office just prior to the meeting.

Special Guest Andrew Alberti of Flatley Reed and Pete Bardunias, President of the Southern Saratoga County Chamber. They discussed many grant options and opportunities for the Village of Stillwater. The Board agreed the opportunities sounded exciting and would be in touch.

Special Guest Jim Ball from Clearwater Pools brought a contract for the Village to sign and stated the pump house is being built and they are ready to go once the weather is warm enough to pour the concrete for the Splash Pad. The Village attorney will review and advise on the contract.

**CORRESPONDENCE** – Letter received from SCWA stating they are raising their rates 1.5 percent, citing their annual rate increase in the agreed upon contract with the Village of Stillwater. Invitations were received from the Newland Wood Fire Dept. inviting the Board and office staff to their annual induction ceremony and dinner to be held 2/23/19 at Longfellows beginning at 6:00 pm.

**FIRE DEPARTMENT CHIEF:** Assistant Chief Mahar reported there were 3 alarms and 4 drills for the month.

**DPW** – Matt reported the Cordero building is almost complete, they are working on trim now. The DPW replaced two of the Victorian street lamps with LED ballasts and bulbs and will be slowly working on replacing more as the cost for each is quite high.

**ENGINEERING –** Ed Hernandez stated he reviewed the monthly reports and there were not any compliance issues. (Report on file)

### **COMMITTEE REPORTS:**

Trustee Basile – Stated he will be giving a presentation regarding the sewer plant history at the next meeting. Trustee Basile's preliminary research for a new fire dept. building, based on a one million dollar loan is \$61,000/year for a 30 year loan and \$76,000/year for a 20 year loan. There is quite a bit to think about for this type of project. Trustee Basile stated he was contracted by EON stating they are resolving a legal matter between EON and NYSEG and expect to apply for a building permit by March. They will also have a PILOT proposal for the Village before then. Trustee Basile analyzed our sewer hauling costs and reported to the Board that we will need to increase the budget line item to complete this fiscal year. It was decided that Ed Hernandez will reach out to DOT to try to get another inspection of the Park Ave. bridge before any decisions are made of what step to take next regarding replacement.

Trustee Campbell – Offered multiple options for sewer hauling truck replacement, used, rebuilt new and new. After much discussion, it was decided the best overall decision would be to replace the truck with a new truck. (Report on file).

**MOTION** to accept the bid by H.L. Gage Sales Inc., Albany, NY to buy a 2019 International truck with a vacuum operated tank used for sewerage removal, under contract # 8996 for the amount of \$157,463.00 with a letter of purchase or voucher to Navistar Inc, 399 Albany Shaker Road, Suite 202, Loudonville, NY 12211, to be funded from the Sewer Debt Service account \*0608, made by Trustee Campbell, seconded by Trustee Basile
