LED Street Light application to NYSEG is complete. They have accepted it and the next step will be NYSEG's contractor coming to Village to make the change at the earliest next spring. The unexpired life payment has reduced to 8k and change. Unfortunately, the changes we wanted to make to add 4 lights and eliminate 4 cannot be accomplished through this program. There is a method to effect the change.

Firehouse team next meeting scheduled for January 8 at 5pm.

Senator Jordan has endorsed our application for funding the water project.

Trustee Nelson – Stated he will be following up on AIM funding at the state level to try to get continued monies annually. He may become involved in the Canal Trail initiatives and other grant opportunities.

Trustee DeMarco – She spoke to Don Warner, Copeland, and the paver he contacted has not responded to his requests and will be contacting another vendor for info and pricing. The

NYCLASS investment has earned \$938 YTD and would like to research investing more of our fund balances.

of Joseph F. Fondano, the owner of property known as 19 Colonial Road, which is located part in the Village of Stillwater (SBL# 243.75-1-2 consisting of \pm 14.39 acres) and part in the Town of Stillwater (SBL# 243.-1-79) consisting \pm 9.7 acres and lands (hereinafter the "Fondano parcel").

WHEREAS, the Village's Form-Based Code does not require a public hearing to act on an application for a lot line adjustment;
