**CORRESPONDENCE** – Mayor Wood-Shaw stated a letter was received from the State Comptroller's Office with The Village's Fiscal Stress scores. For the third year in a row the Village has received a "no designation". This is the best possible group of scores to be in. The Village received a 5.0 for Fiscal Stress and 16.7 for Environmental Stress. Mayor Wood-Shaw also stated that Assemblywoman Carrie Woerner will be awarding Town Historian Linda Sanders a Proclamation at the Village's April meeting honoring her retirement and dedication to the Village.

**FIRE DEPARTMENT CHIEF:** There were 5 alarms and 5 drills during the month of January. There was also 5 alarms and 4 drills for the month of February. The Chief also explained the Fire Department purchased new updated pagers.

**DPW** – Matt R. stated there were two water breaks during the month. The crew has been cleaning up the water plant site and refabricating the sewer jet. They have also been reading water meters.

**BCO** – Issuing an OTR for 24 Major Dickinson Ave. Reminders of the sidewalk law have been mailed and the 33 Lake Street issue has been addressed. CO's were issues for 1 Newland Road and 26 Major Dickinson Ave., along with multiple inspections throughout the month.

**ENGINEERING** – Ed H. reviewed the monthly reports and there were no compliance issues, although the flow was high for both for the month. The Annual Certification for the WWTP has

been submitted to DEC and he has contacted DOT to try to get the Park Ave. bridge inspected again.

#### **COMMITTEE REPORTS:**

Trustee Campbell stated he assisted the DPW in creating the portable light for leftover LEDs from the ice rink. He stated he may try to research leasing a dump truck in the near future.

Trustee DeMarco – Stated she attended the Champlain Canal is expecting to receive some assistance from a representative from Waterford for our portion of the trail. Project Backboard had a meeting on 3/12/19 and the next meeting will be 4/8/19 at 6:30 pm. She stated she has been researching some investment opportunities for the Village and provided some handouts for the Board to review.

The current property is vacant with the exception of a garage structed that will be demolished; and

WHEREAS, the proposed action is an Unlisted action pursuant to the New York State Environmental Quality Review Act (SEQRA) 6 NYCRR Part 617.4; and

**WHEREAS**, the applicant has prepared and completed a Short Environmental Assessment Form (EAF); and

WHEREAS, the Board of Trustees of the Village Stillwater desires to appoint itself as lead agency under SEQRA; and

**NOW THEREFORE, BE IT RESOLVED**, that the Board of Trustees of the Village of Stillwater hereby designates itself as the Lead Agency pursuant to the State Environmental Quality Review Act (SEQRA), 6 NYCRR § 617.6, for the review and evaluation of the application; and

**BE IT FURTHER RESOLVED THAT**, the Board Trustees of the Village of Stillwater hereby authorizes the circulation of the Lead Agency Agreement to Involved and Interested Agencies, indicating the Village Board's intention to serve as Lead Agency, including circulating Part 1 of the Short Environmental Assessment Form (EAF); and

**BE IT FURTHER RESOLVED**, that the Board will hold a public hearing on the proposed application and environmental review thereof on April 16, 2019 at 7:00 PM; and

**BE IT FURTHER RESOLVED**, that the Village Mayor and Clerk are directed to prepare such notifications, publications and referrals as required by General Municipal Law §§ 239-m, 239-n, 239-nn and SEQRA.

#### OPTION 3: BUILD NEW AT DIFFERENT LOCATION

- Hire Architect and design new fire house at different location
- Select new location based on design
- If property not presently owned by Village purchase new site
- Construct new fire house at new location
- Decide what to do with vacated space in present building
- · Make Repairs to existing building
- Finance by debt

**MOTION** for the Board to approve the issuance of a Request For Proposal, to be issued to Architectural Firms experienced in firehouse designs, to prepare a scope and cost for a new Stillwater Firehouse and to identify possible locations made by Trustee Basile, seconded by Trustee Campbell
