The meeting began with The Pledge of Allegiance and a moment of silence.

MOTION to open the public hearing to consider adoption of Local Law No. 1 of 2020, which proposes to amend Article D, Section 1 of Local Law No. 1 of the year 1999 entitled "Village of Stillwater Aquifer Protection Law" made by Trustee Basile, seconded by Trustee Nelson Motion carried 4-0

The amendment to the law was explained by Trustee Basile stating it is to permit septic system installations on Ferry Lane properties, if all NYS regulations are met.

MOTION to close the public hearing to consider adoption of Local Law No. 1 of 2020, which proposes to amend Article D, Section 1 of Local Law No. 1 of the year 1999 entitled "Village of Stillwater Aquifer Protection Law" made by Trustee Nelson, seconded by Basile Motion carried 4-0

MOTION to accept MVP EPO HDHP Silver 8 plan as the Village of Stillwater's health insurance plan, effective 3/1/20, for all eligible employees and retirees. Deductibles to be paid in full by the Village of Stillwater and prescriptions to be reimbursed to each employee until deductible is met. Also, authorizing the Village Clerk to reimburse all eligible prescriptions, at time of submittal, as a prepay to be approved at the next scheduled Village Board meeting and to accept the renewal of existing Delta Dental and Empire Vision Plans made by Trustee Basile, seconded by Trustee Zeno Motion carried 4-0

Eagle Scout candidate Eddie Berthiaume gave an update on his project of installing new benches around the Splashpad. It was decided he will work with Matt Rifenburgh for specifics. Eddie will be fundraising for the project to be completed prior to his eighteenth birthday on April 1.

CORRESPONDENCE - None

FIRE DEPARTMENT CHIEF: There were 6 alarms, 2 training sessions for the month.

MOTION to authorize the purchase of a Chief's vehicle, not to exceed \$7500.00, made by Trustee Basile, seconded by Trustee Zeno Motion carried 4-0

FIRE MARSHALL – Stated he began working on the inspections for the Central and South ends of the Village. The North end only has 4 outstanding inspections out of 22.

DPW – The water plant is being cleaned up and the holiday banners have been removed. DPW only clears the snow away from the road in the business district, from Stewart's to Dom's Pizza. A reminder that all businesses and homeowners are responsible for the snow removal on the sidewalks bordering their properties.

MOTION to authorize the Mayor to enter into a contract for purchase of a compact excavator, per NYSOGS Contract #P67075 and quote #173276, and paid for by \$12,000 in existing budget line item of DPW Equipment Reserve and the balance funded by the general fund balance made by Trustee Basile, seconded by Trustee Zeno Motion carried 4-0

MOTION to approve, as amended, the purchase of a John Deere excavator, not to exceed \$73,000 made by Trustee Zeno, seconded by Trustee Basile Motion carried 4-0

BCO - Absent

ENGINEERING – The monthly water and sewer reports were reviewed. The Village was awarded a 733K grant for the Water line replacement project. It is a 60/40 funded split. The remaining monies to be funded through a low interest loan from the DWSRF program. Ed projects the start date to be summer 2020. He stated an MBO (Minority Business Officer) will be needed for the project. John Basile volunteered, and the Village Board agreed Trustee Basile will be the Village of Stillwater's MBO for the water line replacement project. (Report on file)

COMMITTEE REPORTS:

Trustee Basile – The FD building report is incomplete and not ready for presentation to the board currently. He also requested an executive session for legal advice.

Trustee DeMarco – Stated she assisted with the Christmas tree decorations and had a meeting with Sher to discuss additional NYCLASS investing options.

Trustee Nelson – Stated he met with Trustee Zeno regarding the trail work and will continue to do so next month.

Trustee Zeno – Stated there is not anything new on the Colonial Road Apartments at this time. The planning committee has a new name of "The Stillwater Experience Committee". She has met with Drew from Flatley Reed to build a strategic plan for the Village and discuss housing rehabilitation needs. They are also discussing Main Street grant opportunities and she is creating a beautification committee that will be lead by Trustee DeMarco. She is looking at senior services and updating the employee manual.

WHEREAS, pursuant to the New York State Environmental Quality Review Act (SEQRA), 6 NYCRR Part 617, the proposed action is an unlisted action; and

WHEREAS, pursuant to 6 NYCRR § 617.6, the Village of Stillwater Board of Trustees has previously declared itself lead agency concerning the action proposed by Applicant; and

WHEREAS, the Board of Trustees has completed a Short Form Environmental Assessment Form: and

WHEREAS, a public hearing was noticed and duly held on January 21, 2020 to consider the environmental significance of the proposed action; and

WHEREAS, the Village Board has carefully considered and weighed the input by the public; and

WHEREAS, the Village Board has duly reviewed the EAF and has considered the criteria contained in 6 NYCRR §617.7(c) to determine whether the proposed action will have a significant impact on the environment; and

WHEREAS, the Board of Trustees has considered the criteria set forth in 6 NYCRR 617.7(c), reviewed each of the eleven (11) factors contained in Part 2 of the EAF, and determined that the proposed action will have no, or only a small, environmental impact; and

NOW, THEREFORE, BE IT KNOWN AND RESOLVED, that the Village Board hereby determines that the adoption of Local Law No. 1 of 2020 amending Article D, Section 1 of Local Law No. 1 of the year 1999 entitled the "Village of Stillwater Aquifer Protection Law" will NOT have a significant adverse impact on the environment; and

IT IS FURTHER RESOLVED that the Village Board adopts the findings and conclusion relating to probable environmental impacts contained within the Negative Declaration and authorizes the Mayor and Village Clerk to execute and file the Negative Declaration in accordance with the applicable provisions of law.

Amending Local law 1 of the year 1999 entitles "Village of Stillwater Aquifer Protection Law"

Article D, Section 1 of Local Law No. 1 of the year 1999 is hereby amended to read as follows

1. Disposal of any solid waste, petroleum, radioactive material, brine, solvents, hazardous material, or wastewater into or onto land or a surface water body(except for the underground injection activities specifically and directly related to the development or maintenance of water supply wells and except for the operation of existing on-site disposal systems and except for the installation, operation, or replacement of up to one onsite disposal system for sewage properties adjacent to Ferry Lance). Any water supply wells or on-site disposal systems for sewage shall be subject to and comply with all applicable federal, state or local laws and regulations.
