#### **NEW BUSINESS**

Proposal by Capital District Ventures, engineer Joe Bianchine representing, to construct 24 condos at the old American Linen Property, 950 Hudson Avenue. The proposal consists of 6 buildings with 4 condos in each building, which will be all two and three bedroom units. There will be a condo association for all outside maintenance of each unit. Pigliavento Builders will be the builders involved with the project. (Pictures were presented). It was decided by the Village Board that the application should be submitted in full and we will go from there as far as a time line to establishing a date for a public hearing.

**MOTION** to appoint the Stillwater Village Board as lead agency for SEQR, regarding the application submitted by Capital District Ventures LLC, for proposed condos located at 950 Hudson Ave. made by Trustee Wood-Shaw, seconded by Trustee Marshall Motion carried 4-0

New building and zoning fee schedule was presented by BCO Steve Streeter. A brief explanation was given as to why and how the rates were established. The proposed rates are based upon the current fees charged by Mechanicville, Town of Stillwater and Malta and are comparable. Our attorney made clear the fact that all changes were building and zoning application changes and does not affect water and sewer rates or fees. Questions did arise regarding the proposed project at 950 Hudson Ave. and special permit fees, so it was decided these items would be researched and the topic tabled until the next scheduled meeting. WHEREAS, pursuant to Village Law § 9-904 and New York State Election Law § 15-104, the Board of Trustees must approve the ballot proposition with an abstract thereof stating the purpose and effect of such proposition and (1) at least ten days before the election publish a notice containing said proposition and abstract and (2) at least one day before the election post a copy of such notice in at least six conspicuous public places within the village.

**NOW, THEREFORE, BE IT RESOLVED**, that the Board of Trustees approves the proposition in the form as follows:

Shall the month of the General Village Election of the Village of Stillwater be changed from March to November to coincide with the date of the General New York State Election (the Tuesday next succeeding the first Monday in November)?
