CORRESPONDENCE

Mayor Nelson read a thank you letter from the Stillwater Food Pantry thanking the Village for the donation (Letter on file)

Mayor Nelson stated we received a letter from the Saratoga County Planning Board approving the Comprehensive Plan Amendment.

Mayor Nelson stated clerk/treasurer Tedesco received notification from the State Comptroller's Office stating they had reviewed the 2016 AUD Report and assigned the Village "no designation" meaning the Village does not appears to be in any fiscal stress. (Report on file)

FIRE DEPARTMENT CHIEF: Chief Mahar reported there were 2 alarms throughout the month. Chief Mahar did an inspection of the firehouse with the Fire Marshall. The members fixed the steamer brakes and had some driver training. Chief Mahar also reviewed the insurance policy with Adirondack Insurance Representative, Dave Meager, and all appears to be in order. (Report on file)

DPW – Matt R. reported the DPW was busy from the blizzard last week. The DPW also jetted a sewer line on Russell Drive, fixed a generator at Hillside and were working on reading the water meters. (Report on file)

Mayor Nelson complimented the DPW for the work they did during and after the storm.

BUILDING CODE OFFICER- Steve Streeter reported he had an inquiry about adding an in-law apt. in Franklin Court and issued three CO's for Solar City. He reported he had also been working on the corrections for the license and permit fee charges (Report on file)

ENGINEERING – Ed Hernandez passed around a sample of a lead pipe so the Board could see an example of what has been causing elevated levels of lead in some older homes throughout the Village. He stated we have gotten the petroleum fuel tank at the sewer plant registered as an "out of service" tank and will look into getting it removed in the spring. (Permit is on display at the sewer plant) Ed also stated Capital District Ventures needs to submit their stormwater management plan to Lindsay Zepko prior to a public hearing being scheduled for the condo proposal for Hudson Avenue.(Report on file)

Trustee Marshall – Stated she reviewed the EPA correspondence and is learning.

parking, utilities and stormwater management facilities. A copy of the application materials is enclosed.

WHEREAS, the proposed action has been determined to be an Unlisted action, pursuant to the New York State Environmental Quality Review Act (SEQRA) 6 NYCRR Part 617.4.

NOW, THEREFORE, BE IT RESOLVED THAT, pursuant to the applicable standards of SEQRA 6 NYCRR Part 617.6, the Village Board of the Village of Stillwater concludes that it is the appropriate agency to serve as Lead Agency for the coordinated environmental review of the proposed Unlisted Action; and

BE IT FURTHER RESOLVED THAT, the Village Board of the Village of Stillwater hereby declares its intent to be Lead Agency for the coordinated SEQRA evaluation; and

BE IT FURTHER RESOLVED THAT, the Village Board of the Village of Stillwater hereby authorizes the circulation of the Lead Agency Agreement to the other Involved and Interested Agencies, indicating the Village Board's intention to serve as Lead Agency, including circulating Part 1 of the Full Environmental Assessment Form (EAF).
