**WHEREAS**, the Village Board has carefully considered and weighed the input by the public; and **WHEREAS**, pursuant to SEQRA, the Village Board has prepared and completed Parts 1 and 2 of the Full Environmental Assessment Form (EAF); and

**WHEREAS**, the Village Board has reviewed the environmental findings and recommendations of the Village's engineers and planners with respect to the proposed action, and has duly reviewed the EAF and has considered the criteria contained in 6 NYCRR §617.7(c) to determine whether the proposed action will have a significant impact on the environment;

**NOW THEREFORE, BE IT RESOLVED**, that the Village Board hereby determines that the proposed adoption of the Village Zoning Law will NOT have a significant adverse impact on the environment; and

**NOW THEREFORE, BE IT RESOLVED,** that the Village Board adopts the findings and conclusion relating to probable environmental impacts contained within the attached Environmental Assessment Form (EAF) and Negative Declaration and authorizes the Village Clerk to execute the EAF and file the Negative Declaration in accordance with the applicable provisions of law.

# **RESOLUTION**

### Resolution Adopting Local Law No. 2 of 2017 entitled "Form-Based Code"

Motion By: Trustee Wood-Shaw Seconded By: Trustee Marshall

WHEREAS, the Village of Stillwater Board of Trustees has considered adoption of Local Law No. 2 of 2017, entitled "Form-Based Code" to replace the Village's existing zoning law; and

WHEREAS, the Board of Trustees previously engaged in planning efforts including adoption of the Village Comprehensive Plan Update (2016) and approval of the Stillwater Hudson River Waterfront Revitalization Plan (2016) and the Stillwater Route 4 Corridor Plan (2016). These planning efforts involved participation by Village officials, representatives, citizens and professional consultants; and included cooperation with the Town of Stillwater, Capital District Transportation Committee (CDTC), Capital District Regional Planning Commission (CDRPC), and Saratoga County Planning Department; and

WHEREAS, the Board of Trustees conducted multiple public informational meetings, workshops and hearings on the Form-Based Code, including a joint Village-Town board Public Hearing on March 23, 2017, a Village Board Public Hearing on May 17, 2007 and a Village Board Public Hearing on June 20, 2017, to review and discuss the draft Form-Based Code zoning regulations, transect zones, and design guidelines with the public and thereafter incorporated public comments received during the public hearings into the Draft Form-Based Code; and

**WHEREAS**, the Board of Trustees forwarded the Draft Form-Based Code to the Saratoga County Planning Board, as per the General Municipal Law §239-m, for review and recommendations; and Saratoga County Planning Board approved the Form-Based Code without modification; and

**WHEREAS**, the Board of Trustees, as lead agency, reviewed and fully considered the environmental impacts, together with all written and oral comments thereon, concerning the proposed action in accordance with Article 8 of the Environmental Conservation Law and the State Environmental Review Act (SEQRA), 6 NYCRR Part 617; and

WHEREAS, the Board of Trustees adopted a Negative Declaration with respect to this action on June 20, 2017; and

**WHEREAS**, the Board of Trustees held a Public Hearing on June 20, 2017 to consider public comments on the proposed Local Law No. 2 of 2017 entitled "Form-Based Code"; and

**NOW, THEREFORE, IT IS RESOLVED**, that the Village of Stillwater Board of Trustees hereby adopts Local Law No. 2 of 2017 entitled "Form-Based Code," a copy of which is annexed hereto.

The EFC grant application is due by this Friday 6/23/17 and we are still waiting on the inter-municipal agreement from the Town that we have been promised. The Mayor stated he will get on that tomorrow. There are some stormwater issues that need to be addressed with the Hudson Ave. Condo project. (Report on file)

# RESOLUTION FOR VILLAGE ELECTIONS TO BE CONDUCTED BY THE SARATOGA COUNTY BOARD OF ELECTIONS

WHEREAS, pursuant to New York Election Law § 15-104, the Board of Trustees of the Village of Stillwater may adopt a resolution, subject to permissive referendum, for Village elections to be conducted by the Saratoga County Board of Elections; and

**WHEREAS**, on March 21, 2017 the electors of the Village of Stillwater approved a proposition changing the month of the Village general election to November to coincide with the date of the New York State general election; and

**WHEREAS**, the Board of Trustees has determined that it would be in the best interests of the Village of Stillwater for all Village elections to be conducted by the Saratoga County Board of Elections; and

WHEREAS, the Village Board of Trustees desires to have all Village election districts contained wholly within the Village pursuant to New York Election Law§ 15-104:

**NOW THEREFORE BE IT RESOLVED** that the Board of Trustees of the Village of Stillwater hereby authorizes the Saratoga County Board of Elections to conduct all Village elections and to establish Village election districts contained wholly within the Village; and

BE IT FURTHER RESOLVED that this Resolution shall be subject to permissive referendum pursuant to Article 9 of the Village Law, and shall not take effect until thirty days after its adoption; nor until approved by the affirmative vote of a majority of the qualified electors of the Village voting on such proposition for its approval if within thirty days after adoption of this Resolution there be filed with the Village Clerk a petition signed and acknowledged by electors of the Village in number equal to at least twenty per centum of such electors in the Village, as shown on the register of electors for the previous general village election, protesting against such act or resolution and requesting that it be submitted to the electors of the village for their approval or disapproval; and

IT IS FURTHER RESOLVED that the Village Clerk shall, within ten (10) days of the date of the adoption of this Resolution, in the official newspaper of the Village, in the same manner as is provided for notice of a general Village election, post and publish a Notice, in substantially the form attached hereto, which shall set forth the date of the adoption of this Resolution and contain an abstract of such Resolution concisely stating the purpose and effect thereof, and indicating that such Resolution is subject to a permissive referendum; and

**IT IS FURTHER RESOLVED** that the Village Board hereby authorizes the Mayor and/or Clerk to sign all documents perform such administrative and ministerial actions as may be necessary to effectuate the terms of this Resolution.
