Special Guest – David Meager, Adirondack Trust Insurance

Mr. Meager gave an update on the Village Insurance renewal. Insurance is divided in two parts. Fire company is in "safety group plan" Reciprocal is the other part. The village belongs to the New York Municipal Insurance Reciprocal (NYMIR) and, as a member, this means the village insurance can never be cancelled. NY Paid family leave law was discussed, however municipalities are exempt. Further discussed was Workers Comp and Cyber Insurance. He suggested raising the heavy equipment deductible from \$500 to \$1000 to save \$408. The savings could be used to pay cyber insurance. HR insurance is included at no cost. Mr. Meager advised that Bounce Houses are not covered. Supplemental Bounce House Insurance could be added at no cost.
