## **PUBLIC HEARING**

Mayor Martin called the public hearing to order at 7:00 P.M. He read the notice that was published in the newspaper.

**MOTION** to open the floor to the public and press was made by Trustee Murphy, seconded by Trustee Walker.

Motion carried 3-0

Mayor Martin explained the new law is an administrative law that is required by the New York State Legislature.

John Basile, Hudson Avenue questioned if there was a summary of the changes available to the public.

Mayor Martin advised the changes are mostly administrative.

**MOTION** to close the floor to the public and press made by Trustee Hanehan, seconded by Trustee Murphy.

Motion carried 3-0

**SPECIAL GUESTS:** Ms. Linda Sanders, Village Historian & Ms. Linda Palmieri, Deputy Village Historian.

Ms. Sanders provided information regarding the cavern that was discovered behind the old Stewart's Store. It was originally constructed possibly as a root cellar. She gave a brief summary of the history provided by a former resident.

Ms. Sanders gave her annual report of activities for the year 2006 (copy on file)

Ms. Palmieri gave her annual report of activities as the Deputy Historian and Blockhouse Curator. (copy on file)

The Mayor thanked the Historian and Deputy Historian for their very important work., and their annual reports to the Village.

Ms. Sanders questioned when water would be provided at the Blockhouse. Mayor Martin stated that is for the Town to request from the Village.

# **CAMELOT ASSOCIATES** – Clay Ernst & Dennis Degenaro

Trustee John Murphy introduced Mr. Ernst & Mr. Degenaro to the public; he explained that he had been working with Camelot Associates to bring this project to the Board of Trustees. The original proposal was to include apartments on the second floor which have been eliminated.

A conceptual photo was displayed along with a site plan to be reviewed. Mr. Ernst explained the concept to the Board. Many questions were asked and answered regarding types of stores they hope to attract. They explained there are plans for 75 parking spaces on 3.9 acres, the plan also allows for green space. Questions were asked regarding storage for the Fire Dept.'s steamer.

Trustee Walker questioned if sidewalks were planned along Hudson Avenue. It was explained they were not sure if the Village would want sidewalks in that area. Trustee Walker advised that part of the comprehensive plan is to have sidewalks the entire length of the village along Hudson Avenue.

The Mayor thanked Mr. Degenaro & Mr. Ernst for their presentation.

Mayor Martin called the regular meeting to order at 7:50 P.M. and led the Pledge to the Flag.

#### **CORRESPONDENCE**

Mayor Martin read a letter from David Anusesky requesting water & sewer services to property he owns in the Town of Stillwater adjacent to Colonial Road. Mr. Anusesky explained the property is located approximately 500 feet north of the ice pond, across from Colonial Estates.

Trustee Murphy stated the Village Board had decided they would not longer authorize any new outside connections, Trustee Walker stated we are unable to offer sewer to village residents and could not offer sewer to an outside connection, Trustee Hanehan agreed. Mayor Martin stated he understands the concern for sewer; however, he would give water. Trustee Murphy stated he would be willing to discuss water but not sewer. Trustee Hanehan stated once you change the policy you open the door for more requests. Mayor advised the Board would discuss the matter and get back to Mr. Anusesky.

Clerk Treasurer read a request from the Stillwater Free Library for a donation to provide various programs to the children this summer. Board feels it is not possible to donate as the Library receives tax dollars annually.

Mayor Martin read a thank you from Donald Flynt for the plaque the Mayor presented to him.

Mayor Martin read a thank you to the Dept. of Public Works and the Fire Department for the work they did removing snow during the recent storm.
