Mayor Martin explained the purpose of the meeting is to discuss State requirements as follows: Water Treatment Plant backwash discharge and path for removal, delineation of wetlands, core sampling, and Executive Session regarding Order on Consent.

Discussion was held on the general pathway the Village would take to remove backwash water to the sanitary sewer system.

RESOLUTION

WHEREAS, on February 19, 2008 in executive session the Village Board concluded that the Water Treatment Plant filter backwash discharge path through the Tamzie Travis property should be given one more opportunity to be brought to a successful conclusion within five days, and if not successful, the path to be selected would take the discharge to the Elementary School pump station; and

WHEREAS the pathway through the Travis property will not result in a timely resolution.

NOW THEREFORE BE IT RESOLVED that the Board affirm this decision to have the backwash discharge to the sewer system proceed via the Stillwater Central School System utilizing the Elementary School pump station.

NOW THEREFORE BE IT RESOLVED that the Village Board of Trustees hereby would like to thank Tamzie Travis for her cooperation in trying to set up the pathway through her land.

Freshwater wetland permit may be required so we'll need a delineation of wetlands. Proposals have been received for the Travis lands however the school path is different and the school has already completed a large portion of delineation.

MOTION authorizing the Mayor to enter into a contract with Roberts Environmental Consulting, as per their proposal for wetland delineation and permitting, for an amount not to exceed \$4,600 made by Trustee Basile, seconded by Trustee Murphy.

Discussion held regarding the credentials of Deborah A Roberts PhD who will complete the work. SEQRA will be required and possibly an Archaeological study which are not included in Ms. Roberts' proposal

MOTION to accept Atlantic Testing Laboratories to perform core sampling at a cost not to exceed \$6,000 made by Trustee Basile, seconded by Trustee Walker

Discussion: Proposal covers crew and equipment for two eight hour days to perform soil sampling in the heart of the wetlands with a tripod assembly. We'll need permission from the school as well as Dig Safely. The purpose is to avoid needing to open cut through the wetlands which can be done but is very time consuming. We hope to directional drill under the wetlands and these samples are necessary to give potential drillers clear and concise information on what soil conditions they may encounter. We may want to consider directionally drilling the entire line and the core sampling will enable us to receive more competitive prices.
