Special presentation honoring Clerk Treasurer Margo Partak who is retiring after 17 years of service for the Village of Stillwater. Mayor Martin called the meeting to order at 7:20 P.M. and led the Pledge to the Flag.

Dave Meager from Adirondack Trust Insurance reviewed the current insurance coverage and explained the Fire Department is a separate policy that is renewed in March. Most of our buildings are covered under the blanket policy with the exception of the Firehouse/Municipal building. Mr. Meager advised a terrorism policy is available but the Board agreed it wasn't necessary to add at this time.

## **BUILDING CODE OFFICER** – Lynn Goman

Mr. Goman thanked Margo for all her help before reviewing his written report and explaining the situation at 24 Major Dickinson which should be resolved by the end of the week.

### FIRE CHIEF - Shane Mahar

The Chief reviewed his written report (copy on file) and updated the Board on the status of the 1975 Maxim; the repair costs are expected to be \$2300 when complete and the Board was asked to approve additional funds. Mayor Martin preferred to wait until a final bill is received. After the mechanic is finished, the truck will go to Wilde Fire for painting, lettering, and some safety issues; a quote will be provided.

Tonka will be coming to review, a second frac tank was installed yesterday, and a new check valve was purchased by EPA and is scheduled to be installed tomorrow. A sewer clog was cleared on Park Avenue with the help of the City of Mechanicville.

Trustee Basile discussed the status of the Route 4, Ten Broeck Sidewalk and Storm Water Project. Part 2-Project Impact has been prepared by the engineers and Trustee Basile covered what little impacts there are as follows: this is a proposed action that could result in some physical changes to the project site, a small effect, some water table that would be less than three feet, bedrock may come up above that three feet but is not expected. There is likely not to be any public controversy related to potential adverse environmental impact. Mr. Peluso reviewed the specific no impact items as follows: no impact on water, air, plants and animals, agricultural land resources, aesthetic resources, historic and archeological resources, open space and recreation, critical environmental areas, transportation, energy, noise and odor, public health and community neighborhood.

### RESOLUTION

Accepting SEQR Lead Agency Status and Issuing a SEQRA Negative Declaration for the Planned Route 4/Tenbroeck Street Sidewalk and Stormwater Project

WHEREAS, the Village of Stillwater is proposing construction of approximately 4,900-feet of sidewalk and curbing on Route 4 and Tenbroeck Street along with stormwater collection and management systems; and

WHEREAS, the proposed action has been determined to be an Unlisted action, pursuant to the New York State Environmental Quality Review Act (SEQRA) 6 NYCRR Part 617.4.; and

WHEREAS, the Village Board of the Village of Stillwater prepared or caused to prepare an Engineer's Report fully describing the project and pursuant to the applicable standards of SEQRA 6 NYCRR Part 617 prepared a Full Environmental Assessment Form (Full EAF) evaluating the projects impacts on the environment; and

WHEREAS, on May 19, 2009, the Village Board of the Village of Stillwater declared its intent to conduct a coordinated review and its intent to be Lead Agency for the SEQRA evaluation and provided proper circulation of the Lead Agency Notice to the other Involved and Interested Agencies, indicating the Village Board's intention to serve as Lead Agency; and

WHEREAS, the Village Board of the Village of Stillwater has not received any objections from the involved agencies regarding the Village Board's intention to serve as Lead Agency; and

WHEREAS, the Village Board has completed Part II of the EAF and has considered all reasonably related long-term, short-term, and cumulative environmental effects associated with the proposed action including other simultaneous or subsequent actions; and

WHEREAS, the Village has compared the proposed action with the Criteria for Determining Significance in 6 NYCRR 617.7 and determined that no significant adverse impacts associated with the proposed action have been identified; and

**NOW, THEREFORE BE IT RESOLVED** the Village Board of the Village of Stillwater hereby declares itself lead agency for the purpose of conducting the SEQRA review of the planned Route 4/Tenbroeck Street Sidewalk and Stormwater Project; and
