CORRESPONDENCE – The Mayor shared a note from Mia, who made and delivered homemade cookies for the DPW. A holiday card was received from Senator Jordan. A gift basket was delivered from Cosmo Marfione of BDC Builders, that the Mayor donated to the DPW.

COMMITTEE REPORTS:

Trustee Basile – Nothing new to report on the streetlight project. There will be 2 more units to be connected to the sewer at Castle Cliff on Kellogg Road by Joe Zecca in the coming months.

Trustee DeMarco - No report

Trustee Nelson – Wanted to remind the Board when it is time to vote on the library moving project that people are currently living in the Fiber Mill site and will be put out of their homes if the project passes.

Trustee Zeno – There was a smell reported on December 23, 2020 at the firehouse and Village Clerk's office. The fire dept. members had pulled down the ceiling tiles in the back bay, flat rood section, of the fire dept. the night before to release leaking water and it was assumed that is where the smell was coming from. The Village retained the services of Spectrum Environmental Associates, Inc. to do a mold and air quality assessment of the fire house and the Village Clerk's Office. There was mold identified, but at an acceptable breathing level in the air when tested. There was a report distributed with mold remediation plans and recommendations. The Board is obtaining and assessing estimates for the roof repair to begin the process. Laurence Case stated there may be an opportunity to get two golf cart trucks donated to the Village and is working on the details. BDC Builders are looking for an informal agreement to move ahead with the engineering in preparation for the next planning meeting to discuss the Colonial Road Apts. It was decided that preliminary agreement for the building placement should move forward. The Millennium Miles project will be renamed The Stillwater Experience and it still is in the works to be completed very soon. There was discussion regarding securing a secondary water source in case there was ever an emergency to require one. The Village engineer stated it could not hurt to have one, if it was not a large investment, since it was unlikely it would ever be needed.

A summary of past water supply options was presented by Trustee Basile.

Mayor Wood-Shaw appointed Laurence Case as Bureau Chief of Fire Services and Steve Benders as Fire Inspector for the Newland-Wood Fire Dept for the calendar year 2021.
