The Village Board seeks public input and comment on whether the Village should allow facilities to operate adult-use cannabis consumption sites. The proposed local law does not seek to prohibit the sale of cannabis at retail dispensaries within the Village. The proposed local law is subject to a permissive referendum. Written comments may also be submitted to the Village Clerk prior to the public hearing.
