Proposed Local Law #1 of 2023 was explained as New York State has enacted a 10% property tax exemption for eligible fire and ambulance volunteers; and, the State legislation allows municipalities to accelerate those property tax exemptions by enacting a local law after a public hearing.

Trustee Basile stated the assessment on your home would have to be \$487,00+ to qualify for a greater tax exemption than using the standard \$200 tax deduction, as you cannot claim both deductions.
