**SPECIAL GUEST** – James Doyle, Stillwater Landings, wants to dedicate the roads before winter. He is trying to get the culverts and roads cleaned. The DPW and engineer will review and report back.

**CORRESPONDENCE** – Stillwater Attic Angels is having a backpack giveaway Sunday August 12<sup>th</sup> from 1-4 PM. Their goal is to provide backpacks to all children that need them locally. They are seeking donations from local businesses, along with volunteers for 8/12/23. Joann Boucher, member of the American Legion, would like to conduct a fundraiser on October 14<sup>th</sup> at 4 PM for a walk for cancer and would like local businesses to participate.

Mayor Judy commended the Fire Department for their quick and professional response to the fire last Thursday night on Hudson Ave. They responded in record time and the fire was put out very quickly.

**FIRE DEPARTMENT CHIEF:** (Report on file) There were 5 alarms and 4 training events during the month. Hose testing went well.

**ENGINEERING** – (Report on file) Trustee Basile asked some questions regarding Scenic View sewer hook ups and if that would allow people on Lake Street to also join the Village sewer.

Trustee Basile – The Battery Project is essentially complete. The FD training will be on the 26<sup>th</sup> at 7:00 PM.

Trustee DeMarco – Asked Matt to check the south end planter for sumac.

Trustee Nelson – The canal authority and the bike project will not happen. Technically boats are not supposed to tie up over there, so it won't be workable. Livingston is waiting for funding approval.

Trustee Wood Zeno – Received proposal for email from the company that the Town uses, Edmunds. Their representative, Ryan, came for a meeting with myself and the Village Clerk. Their

proposal is \$2,790.00 for set up and \$1,440.00 as a yearly recurring total. This would bring us all on to the same platform. Trustee Wood Zeno makes a recommendation to subscribe to this service. Trustee Nelson recommend we invite the representative to the next meeting for questions.

Trustee Basile stated he would like to share his experiences - Part 1. He moved here from the Putnam Valley because he had a disagreement with the school board in Putnam Valley because of the high taxing rate. The school taxes went up \$5000 in 3 years. They moved to Stillwater to get away from the high taxes. When he moved here he started going to the SCSD meetings. At that time, they received 50% of their O&M rates from the State of New York, compared to Putnam Valley only receiving 16%. He wanted to get into public service because he could not while he was working full time. He started coming to the VB meetings because he saw some issues with the pump station #1. He was very happy with the way the board handled the situation with a sewer upgrade project. He then became part of the Zoning commission, appointed by Mayor Martin. They worked and put together the new Zoning Law. He decided to run and was elected in 2007, and his major concern was finances. He witnessed some bad dealings with finances at other places. It took two months for him to become secure with his findings of Mayor Martina and Margo Partak. They did a great job of handling the village finances and were well under control. Once on board, he heard that the DEC was concerned about our water plant. The facts are that water plant was an industrial facility and needed a SPDES permit to discharge the backwash into the Hudson River, since it had been doing since the filters were installed in 1990. The DEC put us into a consent order and the Village Engineer, Quinton Koestner, designed for us a treatment system and DEC approved sending the backwash to our sewer plant. The solution was to send the backwash up to the school's pump station, which the school owns. The design was worked out, and an intermunicipal agreement was formed for the school to take over responsibility of the operation and repair for that pump station. During that time the dredging preparations began. The DOH did a study and the water in our 6 wells came from the river. Then the DOH and DEC started testing for the dredging and build up of PCB's as a result of the dredging. We went to bid for the project with an estimated \$900,000, with no grant money involved. July 2008 DOH notified the Village we had PCB'c in our water system. We tested for years and never had found PCB's the EPA changed the parts per trillion to a lesser amount using new and very sensitive test procedures. The EPA forced GE to install 2 carbon filters in the discharge of our water system to remove all PCB's. A quick study would have made our annual expenses jump to a million dollars a year. Based on that, we concluded in the long term we could not continue with the water plant, short term it was not a problem. We stopped the project and notified the DEC of what we were doing. Part 2 to follow at the next meeting.
