RESOLUTION BOARD OF TRUSTEES VILLAGE OF STILLWATER April 16, 2024

Resolution Approving Contact for Purchase of Real Property at 662 Hudson Avenue, Stillwater, NY **WHEREAS**, the Village of Stillwater has steadily expanded over the past decades and as a result the Village Hall municipal office space at 1 School Street, Stillwater, NY, is inadequate to serve the current and future needs of the Village, due in part to the age and condition of the building, inadequate space for the Village's offices, and lack of accessibility to public meeting areas and office locations; and

WHEREAS, the Village of Stillwater requires adequate public facilities that meet the needs of current and future Village residents, including a Village Hall that is modernized and accessible to the public and staff, which is of great importance to the Village and its residents; and

WHEREAS, the proposed use of the property located at 662 Hudson Avenue, Stillwater, NY (formerly the Stillwater Public Library") will allow the Village to upgrade its municipal office space and meeting areas to the benefit of the Village's residents; and

WHEREAS, the Village has explored a host of options to address the above, including renovation of the current Village Hall at 1 School Street, Stillwater, NY, and the current temporary holding of public meetings at alternate sites; and

WHEREAS, after careful consideration of costs related to the above, the Village Board has determined that the purchase of the property at 662 Hudson Avenue, Stillwater, NY, shall allow for the relocation of one or more existing Village Hall municipal offices to a suitable location that provides adequate space and public access; and

WHEREAS, Village Law, §1-102(1) provides that a village shall have the power to take, purchase, hold, lease, sell and convey such real and personal property as the purposes of the corporation may require; and

WHEREAS, the proposed action, the purchase of real property located at 662 Hudson Avenue, Stillwater, NY for use as a village hall and other municipal purposes, is a Type II action under 6 NYCRR Part 617.5(18) ("SEQRA") involving "[r]euse of a residential or commercial structure, or of a structure containing mixed residential and commercial uses" where the use is permitted by applicable zoning laws and does not meet or exceeds any of the thresholds in SEQRA Part 617.4"; and

WHEREAS, the Village Board has prepared and reviewed a proposed contract for the purchase of the property in the amount of \$140,000.00; and

WHEREAS, the Village Board has duly reviewed and considered all other relevant planning, zoning and environmental factors and makes the following findings: Page 2 of 2

 The action is for the purchase of real property located at 662 Hudson Avenue, Stillwater, NY for use as a Village Hall and other municipal purposes; and
The property is presently improved with building on +/-.62 acres;

2. The property is presently improved with building on +/-.62 acres; and

3. The use of the property for municipal purposes is a principal use in the V-4 Mixed Use zoning district, which includes community, government, and municipal buildings; and

4. The parking on site is adequate for the needs of a Village Hall; and 5. The reuse of the existing facilities and improvements on site will result in no significant adverse environmental impacts and will provide the residents of the Village of Stillwater with a centrally located modern and functional Village Hall facility; and

NOW, THEREFORE BE IT RESOLVED, the Village Board of the Village of Stillwater hereby classifies the purchase of real property located at 662 Hudson Avenue, Stillwater, NY for use as a Village Hall, as a Type II action pursuant to SEQRA; and be it further

RESOLVED, the Village Board authorizes the purchase of improved real property located at 662 Hudson Avenue, Stillwater, NY for \$140,000.00 for use as a Village Hall and other municipal purposes; and

RESOLVED, that property shall be purchased with surplus funds to be transferred and withdrawn from the Village's fund balance account; and

RESOLVED, the Mayor is authorized to enter into and execute contracts of sale and

other closing documents to effectuate the purchase.
